

RESOLUTION NO. 2015- 32

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VERO BEACH, FLORIDA, REPEALING RESOLUTION 2009-26; ADOPTING UPDATED RATES AND FEES FOR THE VERO BEACH MUNICIPAL MARINA; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council has determined that various rates, fees, deposits, and charges should not be in the Code of Ordinances and should be established by resolution to the extent permitted by law as provided in section 2-80 of the Code; and

WHEREAS, the City Council must periodically adjust such rates, fees, deposits and charges due to fluctuations in the cost of operating the Municipal Marina and moorings; and

WHEREAS, the City Council finds and determines that the updated rates and fees for the Vero Beach Municipal Marina adopted herein are reasonable and serve a municipal and public purpose,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VERO BEACH, FLORIDA, THAT:

**Section 1 – Adoption of “Whereas” clauses.**

The foregoing “Whereas” clauses are hereby adopted and incorporated herein as forming the legislative findings, purpose, and intent of this Resolution.

**Section 2 – Repeal of Previously Adopted Schedule of Rates and Fees.**

Resolution 2009-26 establishing rates and fees for the Vero Beach Municipal Marina is hereby repealed.

**Section 3 — Adoption of Updated Schedule of Rates and Fees.**

The City Council of the City of Vero Beach, Florida, hereby adopts the "Schedule of Vero Beach Municipal Marina Rates and Fees" attached hereto as Exhibit "A" and incorporated herein.

**Section 4 – Effective Date.**

This Resolution shall become effective upon final adoption by the City Council.



**Exhibit "A"**

**Schedule of Vero Beach Municipal Marina Rates and Fees**

**Marina Rates**

In order to cover the costs of the proper maintenance, operation, and capital improvements to the Municipal Marina, rates shall be charged according to the following schedule (plus applicable taxes):

**SECTION I – WET SLIP, DRY STORAGE AND MOORING RATES**

- A. **Transient Slips:**

| <u>Daily:</u>    | \$1.75 per ft. per day                      |
| <u>Weekly:</u>   | \$10.00 per ft. per week (7 day minimum)    |
| <u>Seasonal:</u> | \$13.15 per ft. per month (4 month minimum) |
| <u>Monthly:</u>  | \$14.50 per ft. per month (1 month minimum) |
- \$97.35 per month liveaboard fee shall apply

Harbormaster approval is required for Seasonal and Monthly reservations; deposit required. No proration.

1. A charge of \$4.50 per day shall be made for vehicles parked overnight in the Marina spaces before the arrival of a transient vessel or remaining the day after the departure of a transient vessel.

- B. **Long-term Slips:**

- C. **Long-term Liveaboard Slips:** \$97.35 per boat per month in addition to per ft. charge.  
(Maximum of 20 liveaboards)

1. Any liveaboard vessel that is absent from its assigned berth for a full calendar month may have the liveaboard fee waived for that period.
2. The named vessel must be absent from its assigned slip for the full calendar month for this waiver to be effective.

- D. **Dry Storage:**      Inside:      \$325.00 per month  
    Outside:      \$250.00 per month  
    PWC:      \$110.00 per month
- E. **Moorings Fee:**      \$324 per month (Long-term), plus \$48.70 per month liveaboard fee  
    \$15.00 per day (Transient) (Includes showers)
1. Transient Moorings are available for a period of up to five (5) days.
  2. Transient Moorings may be available for a period greater than five (5) days (hereinafter "Extended stays") under the following conditions: Owners or Captains of vessels desiring to remain on these moorings for Extended Stays must:
    - (a) Register with the Harbormaster and receive the Harbormaster's permission to remain; and
    - (b) ~~Pay the equivalent of thirty (30) days of the applicable daily transient mooring fee in advance (e.g., \$11.90/day x 30 days = \$357.00; and~~ <sup>TEA</sup>
    - (c) Pay a \$48.70/month facilities fee, in advance. Payment of these fees shall entitle the crewmembers to the use of the dinghy dock and marina facilities for a period of up to one (1) month from the date of timely registration, renewable, subject to the Harbormaster's approval, on a month-to-month basis, up to six (6) months within a twelve (12) month period. Available marina facilities include use of the dinghy docks, garbage disposal, restroom and shower facilities, and parking for up to two (2) vehicles per vessel. No more than two (2) vehicles per moored vessel shall be permitted.
  3. Dinghies from unattended boats on long-term moorings shall be left at the motor-up dinghy dock.
  4. Kayaks and dinghies may be stored on a rack on a space-available basis for a fee of \$16.35 per month.

F. **Facility Building Locker:** \$13.50 per month.

## **SECTION II – ELECTRIC RATES**

A. **Utility Deposit:** All permittees shall pay a \$25.00 utility deposit in advance which shall be retained as a security deposit.

B. **Metered Slips:** \$10.00 per month Readiness-to-Serve Charge plus \$0.17845 per KWH consumption.\*

1. Any vessel that is absent from its assigned slip for a full calendar month may have the electrical readiness-to-serve charge waived for that period.

2. The named vessel must be absent from its assigned slip for the full calendar month for this waiver to be effective.

C. **Non-metered Slips:** \$56.25 per month flat rate where electricity is used.

D. **Transient Rates:** Single 110 volt connection, \$5.00 per day;  
Two 110 volt, or one 220 volt connection, \$8.75 per day;  
Two 220 volt connection, \$22.50 per day

E. **Monthly Transient Rates:** Single 110 volt connection \$56.25 per month;  
Two 110 volt or one 220 volt connection, \$125.00 per month.

## **SECTION III – WATER CHARGE**

All vessels coming to the facility for water shall pay a flat rate of \$5.00

## **SECTION IV – WAITING LIST FILING FEE**

A \$5.00 filing fee will be charged for any applicant requesting to have his name placed on the waiting list.

## **SECTION V – LATE PAYMENT PENALTY**

All payments are due and payable on the first of each month. All fees not paid by the 10<sup>th</sup> of each month shall be increased by a \$25.00 penalty charge per month.

## **SECTION VI – HOLDING TANK PUMP-OUT FACILITY FEE**

A \$5.00 fee shall be charged for each use of the holding tank pump-out facilities. There shall be no charge for this service with a \$50.00 or greater fuel purchase or for vessels permanently moored or docked at the Marina.

## **SECTION VII – FEES & CHARGES EXCLUDE APPLICABLE TAXES**

All of the above fees and charges exclude applicable taxes.

\*Electric consumption rate to be adjusted \$.01 per KWH for each \$0.01 in adjustment in the Fuel Cost Adjustment charge imposed by the serving utility system. Similarly, all adjustments to charges imposed by the utility company as it relates to the \$0.17845 per KWH level that existed in July, 2009, shall be passed on to permittees.
