Aluminum. Performance dimensions – 24'width x 16'depth. Height from deck to canopy: front height of 12' 6" and rear height of 9' 6". Includes stairs with handrail. Additional options include stage backdrop, sidewalls, 12'long equipment ramp, professional lights, and 4' x 4' side stage extensions for speakers. Requires flat surface and 22'wide clearance. Rental is by the day, and pricing includes set up and removal by Recreation Department staff **only**.
