## PERMIT CONDITIONS

The following permit conditions shall apply to the beach services within the service area authorized in the Code Compliance Certification referenced above:

### Permit Conditions

1. The type(s) of beach services and the specific beach area for provision of these services shall comply with the services and area designated in the Code Compliance Certification.
2. No fences, barriers or permanent structures shall be constructed or installed on the beach.

3. No electrical or water service shall be provided.
4. Except as required for alcoholic beverage services, no signs shall be authorized without approval by the Planning Director.
5. All surf or paddle boards, watercraft, float devices and other similar recreational amenities and all beach chairs, tables, tents, and other beach furniture and accessories shall be removed from the area at time of closing each day and stored off the beach, landward of the dune line or the easternmost building line.
6. All trash or other debris shall be removed and properly disposed of daily.
7. 10 foot by 10 foot “pop up” tents or canopies with sides are permitted provided the stakes to secure such are no longer than 10 inches in length.
8. During turtle season, March 1<sup>st</sup> through October 31<sup>st</sup>, every effort shall be made to limit items that sink into the sand or disrupt turtle nesting activity.
9. No indirect or direct lighting of any kind shall be allowed after dusk east of the dune line. Any questions should be directed to the Indian River Environmental Specialist at 226-1259.
10. No animals, except service dogs, shall be allowed.
11. No cooking or fire is allowed.
12. No glass containers, plates, serving dishes, or other glassware shall be used.
13. No straws shall be used.
14. No loud music or other objectionable noise or amplification is permitted.
15. No motorized watercraft is permitted.
16. This permit shall expire on the date shown below or on the date new beach permit regulations are enacted by the City Council whichever comes first.
17. Any violation of the permit conditions or City Code may subject the applicant to code enforcement proceedings and/or revocation of the permit by the City Manager.

**Alcoholic Beverage Conditions**

1. Alcoholic beverage service and consumption of alcoholic beverages shall only be within area depicted in the approved Code Compliance Certification and within the licensed premises of the applicant's alcoholic beverage license.
2. Alcoholic beverages shall only be served in conjunction with food.
3. Alcoholic beverages shall be served only to patrons/guests who are seated at tables or lounge chairs.
4. No alcoholic beverage shall be brought into the designated beach service area except by employees or staff of the permit holder.
5. Signs shall be placed on the perimeter of the beach area where alcoholic beverages are to be served and consumed that warn patrons "no alcoholic beverages may be taken or consumed beyond this sign." Such signs shall be no larger than 3 square feet in size.
